Please inform the photographer if you do not wish to be photographed or filmed in individual cases. You can also contact us at any time afterwards to object to the use of the photographs.

Your personal data will be processed as follows in this context:

#### 1. Personal data

If you are depicted in the above-mentioned photographs, these photographs contain personal data relating to you. According to Art. 4 No. 1 of the EU General Data Protection Regulation (DS-GVO), personal data is any data relating to an identified or identifiable natural person.

## 2. Responsible party

The controller responsible for data processing within the meaning of the DS-GVO and other data protection regulations is

## 3. Purposes

The photographs and video recordings are made for public relations purposes. The event takes place annually. The recordings allow all interested parties to gain a better impression.

### 4. Legal basis

The legal basis for the processing is Art. 6 para. 1 subpara. 1 lit. f DS-GVO, as the processing is necessary to safeguard the interests of the controller and outweighs the interests of the data subjects in the protection of personal data. We naturally take your interests into account and avoid the publication of unfavorable images and comply with requests to delete, obscure or refrain from publication.

### 5. Storage period

The images remain available on the KIT website for a period of up to five years and are then deleted or archived in accordance with Art. 5 para. 1 lit. e DS-GVO.

# 6. Your rights

You have the right to object to the processing of your personal data in accordance with Art. 21 DS-GVO.

You also have the following rights vis-à-vis us with regard to your personal data:

Right of access (Art. 15 DS-GVO)

Right to rectification (Art. 16 DS-GVO)

Right to erasure (Art. 17 DS-GVO)

Right to restriction of processing (Art. 18 DS-GVO)

You have the right to lodge a complaint with a supervisory authority about the processing of your personal data by the Karlsruhe Institute of Technology (KIT) (Art. 77 DS-GVO). In the case of manifestly unfounded or excessive requests, we may charge a reasonable fee. Otherwise, the information will be provided free of charge (Art. 12 (5) DS-GVO). In the event of reasonable doubt as to the identity of the person asserting the above rights, we may request additional information necessary to confirm the identity (Art. 12 para. 6 DS-GVO).
